<u>Junior Achievement Career Day-</u>JA asked Becca for LSWA to support their Career Day (resources, apprenticeships, etc.). Last year LSWA gave \$12,000 for supplies, food, and bussing students. JA plans to separate Career Day event from the JA Inspire event.
